The Regular Meeting of the Carbon Cliff Board of Trustees Village Hall – 1001 Mansur Avenue – Carbon Cliff, IL October 16, 2018

Village President Hintz called the meeting to order at 7:08 p.m.

Village President's Agenda items discussed:

• Jim Taylor with Carpentier, Mitchell, Goddard & Company, LLC, presented the Village of Carbon Cliff's Annual Audit for Fiscal Year Ending December 31, 2017.

The Audit for FYE December 31, 2017 was finished later than normal, due to problems with closing out old info from Peachtree / Sage 50 Accounting software when closing accounts at Triumph Bank and opening all new accounts at Blackhawk Bank and Trust.

The Annual Financial Report is ready to electronically file with the Illinois State Comptroller's Office as soon as this Audit is approved by Village President Bill Hintz.

- Water Main Valve Replacement Project will be awarded to Walter D. Laud for a total base bid of \$64,526.74.
- Had much discussion on the Food Basket Program, it was decided to put the items about the Food Basket Program on the Board Meeting Agenda for November 20, 2018.
 - o To disband the Carbon Cliff Food Basket Program effective immediately.
 - O Donate in the amount of \$1,767.61 to the Carbon Cliff United Methodist Church food basket program. (This maybe a different dollar amount at time of actual time of donation).
 - Close the Carbon Cliff Food Basket checking account at Blackhawk Bank & Trust.
- High lift pump in Pump House A is bad and needs repaired or replaced. Estimate to repair is \$3,447.00 with only a 90-day warranty and the pump motor is still old; new Grundfos Pump Model #A96523627 (10 HP, 406 Volt, 3 Phase) 1-year warranty, new Pump also has the packed sealed bearings and will not need maintenance as the old one would. Board feels it is best to purchase the new pump with longer warranty and new motor.

Correspondence:

• The Village received a nice Thank You Card from Rock Island County Sheriff Bustos for our donation to the Cops and Kids at Christmas Program.

Meetings / Conferences:

• D.O.C.A.S. Nick Gottwalt plans on attending the 11th Annual Upper Mississippi River Conference, October 24 – 25th, 2018 at Stoney Creek Hotel & Conference Center, Moline, IL. Carbon Cliff's paver streets will be featured in one of the tours.

Old Business items discussed:

- Three of the four stormwater inlet drains in Mansur Wood Addition have been repaired and the last one should be completed within the following week. There have been no major problems.
- G.A. Rich has installed the new hatch and Cla-Val control for altitude valve at water tower. Donner Company is set up to come in on Wednesday 10/17/18 to train our maintenance on how to operate the valve.
- The Village received \$21.00 in court fines from a 1991 ticket and \$216.00 in court fines from a 1992 ticket.
- The property at 750 N 2nd Avenue is in the processing of being purchased from Vibrant Credit Union. Vibrant has contacted the Village for a payoff to release the current lean on the property. The lien consists of past due water and sewer bills not paid, new water meter (previous owner had heat shut off and water pipes and the water meter froze.)
- Mid-American Energy replaced the Village's gas meter at 101 1st Street, Pump House A, and it was found to be running 2.11% higher. Credit will be on the next Mid-American Energy bill for \$20.36 and \$0.27 interest for the overcharged amount from June 2016 to May 2018.
- D.O.C.A.S. Gottwalt had meet with Blaze Restoration a Service Master Co. about gutting the old Village Hall at 106 1st Avenue. They will remove and dispose of all materials and items in the building down to the bare walls and flooring, then sanitizing the inside with bleach water.
