

Carbon Cliff Board of Trustees Meeting Minutes 1001 Mansur Avenue, Carbon Cliff, Illinois January 19, 2021 @ 7:00 p.m.

Village President Bill Hintz called the meeting to order at 7:02 p.m.

1. Village President's Agenda items discussed:

- a. Informational January 5, 2021 the Village ordered and received 45.4 ton of ice control salt. As a reminder we requested 100 ton for the 2020-21 Winter Season, we are obligated to take at least 80% and we can receive a maximum of 120%. The Village can still receive between 34.6 ton and 74.6 ton before June 1, 2021.
- Informational Letter received January 15, 2021 from the IL-EPA regarding Violation Notice No W-2020-00009 (Radium). By February 15, 2021, the Village must submit an Application for Construction Permit, Plans, Specs, Design Summary & Corrosion Control Study to IEPA Permits. (Construction of the Reverse Osmosis Treatment Plant must be started by 11/15/2021) We are behind on schedule due to COVID-19, engineer is aware of timeline.

2. Meetings / Conferences (Currently being held virtually):

a. Illinois Association of Floodplain & Stormwater Management Annual Conference. March 10-11, 2021. This conference is scheduled to be a virtual conference. Nick will be attending to keep current with floodplain regulations.

3. Committee Meetings:

- a. Public Properties Committee:
 - 1. DOCAS looking into Chromebook for future use. Committee approved 3-0.
 - 3. Generator four years ago was \$79,000.00. Checking with Bi-State for any available grants. Sprinkler and marquee need to be in budget for 2022.
- b. Public Works Committee:
 - Motion to approve the purchase of a MRX920 Data COL V4 (Meter Reading Antenna) from Ferguson Waterworks in the amount of \$8,393.00. (Antenna will be attached to one of the Maintenance Trucks so that water meters can be read more frequently)

a. DOCAS Gottwalt spoke with the company who did Colona's war memorial and they will be stopping down at Village Hall and putting together a proposal of designs and pricing for getting a memorial wall put up in the Village Hall board room. Hoping to have an update by February committee meetings. Will update board accordingly.

a. DOCAS Gottwalt received a phone call to purchase all of wooded area from behind Silvis Wal-Mart all the way down to 84. Interested buyer asking questions about what he may be able to do on the property and/or future developments. Currently zoned residential and discussed rezoning into commercial use. Discussed alternative access to property – will further discuss with IMEG.
