## 5. Village President's Agenda

- a. Discussion on the status of the Maintenance Department. Mitch Ellison and Marcus Martin have done a tremendous job despite their short time with the Village. The Village would like to show full support of Mitch and Marcus and give them time to get further acquainted with the maintenance department and provide them with any additional training they may require. Mitch and Marcus will be our only two full-time employees, however, we will reassess in the Spring of 2022 as to whether a third full-time employee is truly needed. In the meantime, DOCAS Nick Gottwalt will put an ad out for part-time snowplow help this winter. The Village Board also agreed it's in the best interest of the Village to move forward with ION Environmental Solutions after reviewing references. Nick Gottwalt will reach out to other municipalities ION has worked with to obtain feedback and opinions.
- b. Village Board approved a motion to hire McClintock Trucking & Excavating to replace & update eight hydrants in town. McClintock came in at lowest bid for Time & Materials to do the job. Nick Gottwalt will coordinate with McClintock on getting the hydrants scheduled for replacement.
- c. Informational Carbon Cliff was notified by the Illinois Department of Commerce that we are eligible to receive \$266,042.82 from the American Rescue Plan Act (ARPA). This is a preliminary value. Clerk Neblung has submitted the proper paperwork to claim our portion. More information on how we can spend our allotment will be presented at Committee. Nick informed the Board on a few options we may want to pursue with our funding; however, more information will be provided at the Committee meetings in August. No decision on spending needs to happen immediately but should be determined by the end of the current fiscal year.
