• D.O.C.A.S. While on site Dan authorized them to repair the weather strip, bolts, and latch handle for a cost of \$450.00. This will be added to the final invoice. They also noted that a vent was beginning to show signs of rust and should be repaired. They will provide us with a quote for cost of repair.
