



# Carbon Cliff Board of Trustees Meeting | 1001 Mansur Avenue, Carbon Cliff, Illinois | December 7, 2021 @ 7:00 p.m. | MINUTES

Village President Bill Hintz called the meeting to order at 7:02 p.m.

Members Present: Keith Curry, Robert Dreher, Alma Neels and Larry Scott

Members Absent: Todd Cantrell, Leevon Harris,

Others Present: Nick Gottwalt Director of Community and Administrative Services, Village Clerk Carly Neblung, Loren Rains with IMEG, Chad McCleary with ION, and Liane DeVore, financial consultant, via telephone.

Chad McCleary with ION presented his monthly report. The report is filed and a part of these official minutes. See attached.

#### 5. Village President's Agenda

- a. Presentation of tentative 2021 levy figures (2021 taxes paid in 2022). Determination of Truth in Taxation Act, and setting of Truth in Taxation Hearing, if needed. It was discovered that the Village Board and Staff approved the 2020 tax levy using the tax figures from Carbon Cliff Barstow School District showing us at a higher valuation. With that information, we redid the tax levy with what it should have been for 2020 and are sticking with the same tax rate with no increase to property taxes. This decision is made knowing that a review of the utility system billing rates will be coming in 2022.
- b. Tabled and no Motion to set Public Hearing on the Tax Levy for Fiscal Year January 1, 2022, and ending December 31, 2022, for 7:00 p.m. on December 21, 2021, and to give notice of this hearing in publication in the Dispatch at least one week prior to the time of the hearing. (*Required by law if the taxes are raised more than 5%*).
- c. Budget Officer, Liane DeVore presents the Tentative Budget for Fiscal Year 2022.
- d. Approved Motion to publish the Tentative Budget for Fiscal Year 2022, by publication in the Proceeding of the Corporate Authorities, and by posting at the Village Hall, for at least ten (10) days prior to the passage of the Annual Budget.
- e. Approved Motion to set the Budget Hearing for 7:00 p.m. on December 21, 2021, at the Village Hall, 1001 Mansur Avenue.
- f. Update from Village Engineer Loren Rains. The 1st Avenue culvert box located at Argillo Creek passed inspection and they are concerned with the current centerline of the creek flowing directly into the wingwall and then diverting at the wingwall to flow through the box. The reason why this is an issue is as the creek raises and velocities increase, the flow will want to jump the wingwall instead of turning to go through the box. When the water jumps the wingwall then it will continue to scour out the road. If we fix the road, it is unknown to how long the road will last. Worst case scenario would be the first major rain event and best-case scenario would be 3-5 years. The Village has budgeted \$45,000.00 in the 2022 budget for either gabion baskets or sheet pile for the stabilization of the creek.
- g. Approved Motion to adopt Ordinance No. 2021-15 "An Ordinance Authorizing Execution Of An Intergovernmental Agreement For Law Enforcement Services Between The Village Of Carbon Cliff And The Rock Island County Sheriff's Department."
- h. Approved Motion to approve hiring Tyson Nylin for seasonal part-time snowplow help. Tyson applied after the last Board Meeting. Employee Mitch Ellison has known Tyson for some time and stated he's a hard worker who has the

- experience and is willing to help this season. DOCAS Nick Gottwalt conducted a phone interview with Tyson and felt he would be a good fit this winter season.
- i. Informational The State of Illinois has reallocated unclaimed funds from municipalities that did not submit their request for the American Rescue Plan Act funds and the Village will receive an additional \$137.42.
- j. Informational Rock River Harmony Housing LLC will be filing for a property tax exemption. If the exemption is accepted, the Village stands to lose about \$13,000.00 a year in property taxes.
