Meeting of the Carbon Cliff Board of Trustees | 1001 Mansur Avenue, Carbon Cliff, Illinois June 21, 2022 @ 6:00 p.m. | MINUTES

Village President Bill Hintz called the meeting to order at 6:00 p.m.

4. Hearing of the Citizens

a. Residents along Old Colona Road would like to discuss the ownership of the private drive/alleyway that runs behind their houses. Residents have stated that the Village has maintained this roadway in the past, however, no maintenance has occurred in the past several years. Going through Village records, this has always been a private drive. The main issue seems to be that the residents of the private drive have an issue with surrounding neighbors allowing motorists to use the private drive to access yards offering parking for the John Deere Classic. The residents profiting off the parking are not the ones responsible for maintaining the private drive. It is determined at this time that the roadway will remain a private drive. There is no benefit to the Village to assume control and maintenance of the private drive. The residents that own and maintain the private drive are allowed to place "no trespassing" signs and rope off the private drive at their property lines. The Village also advised the residents in attendance that any issues between the neighbors would be a civil matter and the Village could not be involved.

5. Village President's Agenda

- a. Discuss options for Old Colona Road (private drive/alleyway). The Village took no action on this item as it was determined in the Hearing of the Citizens that this was not a Village owned roadway and there was no benefit to the Village to make it an official roadway.
- b. Langman Construction will begin resurfacing the 5/6th Street Alley, 3/4th Street Alley, Denhardt Alley, and the west end of State Street on June 27th. According to MFT paperwork, the project will be completed in ten working days. The Village has sent out letters to homeowners notifying them not to park in the alleyway during construction and to use an alternative route for travel. During this time residents need to place their trash totes on the street in front of their house for collection.
- c. Motion to restrict parking (No Parking) on the following streets: Old Colona Road from Troy Drive to the East, Old Colona Road from Troy Drive to the West to and include Villa Pines Circle, all of Troy Drive beginning at new Colona Road, all of Orchard Lane, Oakwood Court, Lincolnwood Drive, Lindenwood Avenue, Woodlawn Avenue, Whispering Oaks Court, and Kingsbury Drive from June 27, 2022, to July 3, 2022, in accordance with Title II, Article 4, Section 24 of the Village Code. (Maintenance will post No Parking Signs by the end of business on June 24th)
- d. Motion to waive the bidding process for towing service designated under Title II, Article 4, Section 25 of the Village code, and name Quad City Towing, Inc., 2550 5th Street, Rock Island, Illinois as the designated authorized agent in accordance with Title II, Article 4, Section 25.4, of the Village Code, and shall name Quad City Towing, Inc., 2550 5th Street, Rock Island, Illinois, as authorized garage in accordance with Title II, Article 4, Section 25.5(b) of the Village Code.

e. The Carbon Cliff Sports Club notified the Rock Island County Sheriff's Office that someone had broken into the Concession Stand at the large baseball field late Wednesday night and discovered Thursday. Deputy Reagan with the Sheriff's Office contacted Village Director, Nick Gottwalt and both Nick and Village President, Bill Hintz, stopped to look at the damage. Open for further discussion.
