Currently this property is zoned Residential, however, the prospective buyers were curious about running a dog daycare on this property. Under the current zoning, this is not allowed. There will be a three-month review with the option to increase the salary to \$37,000 should the Board so choose. Meagan's first day will be Monday, September 26, 2022.

- A. Iowa Interstate Railroad stopped in on Wednesday, September 14, 2022, they will be closing and replacing the crossing on N. 1st Avenue, tentatively September 28 30th. While they were in my office, I asked them about installing a culvert underneath the railroad where the creek takes a bend. Jeremiah, our local roadmaster, didn't have a problem with this at all, although he gave us a higher ups information so we can contact him directly. Nick spoke with Loren, Village Engineer, and Loren will make contact on our behalf.
- B. Lakewood Electric will begin running the interior electrical for our generator starting Thursday, September 15th and the current ship date of our generator shows October 3rd. We still need to get the gas line ran from the meter.
