ORDINANCE NO. 15-31

AN ORDINANCE AMENDING TITLE VI, ARTICLE 9, SECTION 5, PARAGRAPHS 5.1, 5.1(a-d), 5.2(b) AND 5.2(b)(1) OF THE VILLAGE CODE (SEWER RATES).

WHEREAS, the President and Board of Trustees of the Village of Carbon Cliff deem that the Village needs to keep current its basic user rate for sewer service; and

WHEREAS, the City of East Moline has adopted an Ordinance increasing the cost of processing the Village's sewerage from \$2.71 per 100 cubic feet of metered sewer to \$3.05 per 100 cubic feet of metered sewer effective January 1, 2016

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Carbon Cliff that:

SECTION ONE: Title VI, Article 9, Section 5, Paragraphs 5.1, 5.1(a-d), 5.2(b) and 5.2(b)(1) are

hereby deleted;

SECTION TWO: Title VI, Article 9, Section 5, Paragraphs 5.1, 5.1(a-d), 5.2(b) and 5.2(b)(1) of the

Village Code shall be as follows:

I. <u>SEWER RATES</u>. Commencing January 1, 2016, there shall be and there is hereby established a basic user rate for the use of and for the service supplied by the wastewater facilities of the Village.

TITLE VI, ARTICLE 9, SECTION 5.1.

- (a) A minimum charge of **TWENTY-NINE DOLLARS AND EIGHTY-FOUR CENTS** (\$29.84) per month shall be applied to all residential metered users for the consumption of the initial Two Thousand Five Hundred (2,500) gallons of water. In addition to the minimum charge, a basic user rate of **SIX DOLLARS AND EIGHTY-THREE CENTS** (\$6.83) per One Thousand (1,000) gallons shall be applied to all water consumed in excess of the initial Two Thousand Five Hundred (2,500) gallons per month passing through the meter.
- (b) For multiple home units occupied as residential units and served by a single meter, a minimum charge of TWENTY-NINE DOLLARS AND EIGHTY-FOUR CENTS (\$29.84) shall be applied per month on the first unit and a minimum charge of FOURTEEN DOLLARS AND NINE CENTS (\$14.09) shall be applied for each additional unit served by the meter for the consumption of the initial Two Thousand Five Hundred (2,500) gallons of water per month. In addition to the minimum charges, a basic user rate of SIX DOLLARS AND EIGHTY-THREE CENTS (\$6.83) per One Thousand (1,000) gallons shall be applied to all water consumed in excess of the initial Two Thousand Five Hundred (2,500) gallons per month passing through the meter.
- (c) A basic user charge of **FORTY-SIX DOLLARS AND EIGHTY-NINE CENTS** (\$46.89) per month shall be applied to all non-metered users. A non-metered user is one where only sewage use is available, no village water is used, and water consumption is not metered.

(d) A minimum charge of **ONE HUNDRED TWENTY DOLLARS AND SEVENTY-SEVEN CENTS** (\$120.77) per calendar quarter shall be applied to the consumption of the initial Ten Thousand (10,000) gallons of water to all commercial users zoned for the Village zoning purposes as C-1, C-2, I-1, I-2, and including all restaurants and industrial zoned users. In addition to the minimum charge, a basic user rate of **THIRTEEN DOLLARS AND SIXTY-TWO CENT** (\$13.62) per One Thousand (1,000) gallons shall be applied to all water consumed in excess of the initial Ten Thousand (10,000) gallons per calendar quarter passing through the meter.

TITLE VI, ARTICLE 9, SECTION 5.2.

- (b) All persons who qualify for Senior Citizen's Rates, both metered users for water consumption and non-metered users for water consumption, shall pay the following basic Senior Citizens' Users Rate:
 - (1) A basic Senior Citizens' Users Rate of TWENTY-NINE DOLLARS AND EIGHTY-FOUR CENTS (\$29.84) for each month or EIGHTY-NINE DOLLARS AND FIFTY-TWO CENTS (\$89.52) per quarter.

SECTION THREE: This ordinance shall be recorded in the Recorder's Office, Rock Island County, Illinois.

SECTION FOUR: This ordinance shall be in full force and effect from and after its adoption, approval and publication in pamphlet form as required by law.
