ORDINANCE NO. 12-29

“AN ORDINANCE AMENDING TITLE II, ARTICLE 7, SECTION 20 OF THE VILLAGE CODE, GARBAGE COLLECTION FEES.”

BE IT ORDAINED by the President and Board of Trustees of the Village of Carbon Cliff, Rock Island County, Illinois as follows:

SECTION ONE: Title II, Article 7, Section 20 of the Village Code of the Village of Carbon Cliff, Illinois, is hereby deleted.

SECTION TWO: Title II, Article 7, Section 20 of the Village Code of the Village of Carbon Cliff, Illinois, shall be as follows:

“GARBAGE COLLECTION” Every residence shall pay a quarterly fee for garbage and trash collection and disposal as provided by the following schedule:

(A) As of July 1, 2012, the following schedule shall be in effect:

SECTION THREE: These fees shall pertain to any and all bills issued after the effective date of this Ordinance.

SECTION FOUR: The fees established in this Ordinance shall be retroactive to July 1, 2012.

SECTION FIVE: That this ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form, published by authority of the Corporate Authorities, as provided by law.
