The bid was awarded to McClintock Excavating at the January 2, 2024, Board Meeting. Project Cost \$152,000.00. Contracts signed off on January 22, 2024. Construction Date set for:

USDA Loan Projects (PER)

Loren has provided us with the estimated costs for the additional water main replacements to be added to our USDA Loan (Mansur to Water Tower, 3rd Street to Valley View, Old Colona Road, and IL84 Phase 2). Loren has also reached out to USDA. The following will need to be addressed:

- Letter from the village requesting a change to their project.
- Amended PER (Sect 6), new project cost, new timeline to get to bidding and construction, with any pertinent exhibits, maps, etc. We can look at the additional water system work but again the need and costs need to be outlined in the PER.
- New ER, depending on what construction is needed.
- Letter of intent from East Moline and eventually water purchase contract.

Security Upgrades for Village Hall

Plans and Pricing have been received. We will need Board Approval before moving forward. Safe Routes to School (Eagle Ridge)

Concept Plans and Phase I & II Cost Estimates were presented to the Committee in October 2023. Salt Storage Building We are working with IMEG on a design for the roof to be constructed in the Spring. Design contract signed with IMEG with a deadline of March 15th.
