## 2024 Spring Hydrant Flushing & Valve Exercising Schedule

<u>CARBON CLIFF</u>—Beginning April 14th, Carbon Cliff Public Works will begin inspecting and flushing hydrants to ensure they are in good working order and remove sediment buildup within the distribution system. The schedule below will let you know when we will be in your area. Flushing will be done between 8:00 a.m. and 3:00 p.m., Monday through Friday.

The Village recommends that you do **NOT** wash any laundry during the scheduled time hydrants are flushed in your area. Hydrant flushing can stir up rust; you do not want that in your washing machine. If there is any discoloration in your faucet water, please let it run for a few minutes, preferably from the tub spout. This should clear up your water and remove any remaining rust and dirt particles. Once you have clear water in your faucet, it is safe to do laundry. Residents may wish to run an empty rinse cycle in the washing machine before doing laundry.

Hydrant flushing is a good time of year to remove and clean the screens on your faucets if they are prone to calcium, lime, and rust buildup. The water is safe to drink during this time.

<u>Valve Exercising</u>. In conjunction with hydrant flushing, the Village will exercise water main valves near each hydrant. This is done to ensure that our lines can be isolated during water main breaks or scheduled repairs. As the valves are exercised, there may be short periods of low or no pressure.
